Our mission at World Class Athletics PCB is to teach respect, promote physical fitness and the sport of cheerleading. We feel that cheer is more than just a sport. It creates long-lasting friendships and teaches kids valuable lessons in teamwork and sportsmanship. Our goal is to help mold our athletes into amazing members of society as they progress through our program and into their future endeavors.

Welcome to World Class Athletics PCB! World Class is a privately owned organization which focuses on competitive cheerleading and dance. These guidelines are to help you understand the rules and standards that allow us to operate a championship caliber All-Star program. If you feel that you cannot accept these guidelines, we understand as a staff this may not be the program for you and/or your child.

We will have travel teams, limited travel teams, and non travel teams for the 2021-2022 season. Everyone makes a team, tryouts are for team placement. If you prefer to be on a non travel or limited travel team, please make sure to put that on your tryout form. Our teams are strictly competition/performance groups. The primary focus will be to prepare & compete in national competitions. Teams also participate in several local/regional competitions, demonstrations, and exhibitions. During the course of this season, the teams will focus on all of the components of competitive cheer including (but not limited to): tumbling, jumps, motions, pyramids, stunts, dance and showmanship.

After the tryout process, each athlete will be given a level (1-7) to practice with throughout the month of May & June. This will allow athletes to work skills in those levels before announcing team placements. This will allow the coaches to see if each athlete is confident and consistent for that level. All levels are important and we must place athletes where they are throwing skills with confidence AND excellent technique. This will help all teams be competitive for their division throughout the season. **If you did not turn in a birth certificate during the 2021-2022 season, you must provide a copy at tryouts.**

All balances must be paid in full in order to try out. The \$175 tryout fee includes the annual registration fee of \$50 + \$125 pro rated May tuition. Throughout the month of May & June, we will have practices by skill level (not age) to further evaluate athletes until teams are formed. Team placements will be announced July 1st & team practices will begin the week of July 5th. Athletes will be placed on teams they are able to perform all skills with confidence.

World Class Athletics understands that no one is perfect. However, we do expect all athletes and parents to be respectful throughout the 2021-2022 season. As an All-Star Program, World Class will continue to strive for perfection while maintaining an enjoyable and rewarding atmosphere for our athletes and families. If cheerleading becomes unpleasant for you or your child, please schedule a meeting with the World Class Athletics Staff. Most problems can be solved in a professional and adult manner when brought to the attention of the staff. Please do not expect a situation to change without bringing it to the attention of World Class Athletics.

Automatic Payment

Monthly tuition will be billed to your World Class account on the 25th of each month for all athletes. The card on file will be set up to automatically pay the tuition fee on the 25th of each month starting May 25, 2021. If you would like to use a different payment method, tuition fees must be paid before the 25th. World Class Athletics PCB accepts cash, debit, checks, and all major credit cards. You may also pay online through the parent portal at www.worldclassathleticsllc.com.

World Class Athletics Financial Stability Clause

If for any reason your account gets behind, we have built in some extra time to get these amounts paid. In an effort to keep account balances at a manageable level, World Class Athletics PCB has implemented a Financial Stability Clause. For the 2021-2022 season, balances must be below a certain dollar amount in order for each cheerleader to continue to participate in practice and/or perform at competition.

The measurement dates are as follows and are based on what has been billed through that date:

Information for Non Travel (Novice) & Limited Travel (Prep) Teams

Non-Travel & Limited Travel teams will be offered for the 2021-2022 season. This is a great way to experience All Star cheerleading with less financial obligations. The Non Travel teams will attend one day competitions & will remain in Bay County and the surrounding areas for all events. Limited Travel teams will attend one day competitions in Bay County & the surrounding areas plus 2-3 out of town events. Non Travel & Limited Travel athletes will have 1 practice per week and 1 tumble class per week.

Information for Travel (Elite) Teams

World Class is one of the top competitive cheer gyms in our area so our travel teams will attend a number of out-of-town events as well as local events. The 2021-2022 competition schedule will be released during the summer time to give our families time to plan accordingly for the competition season ahead. Cheerleaders will travel with their parents to these competitions and stay in a hotel room with their parents. There is usually a block of rooms secured at a hotel under "World Class Athletics PCB" for parents to book their own rooms within this block. If it is not a Stay to Play event, you may book a hotel of your choice. We will send out more details on room blocks once we have that information available. All World Class athletes are required to travel several times per season. Please keep in mind that your athlete may be missing a few days of the school year. Please keep up with assignments, homework, and attendance throughout your 2021-2022 school year so these travel days do not inconvenience your child's academics. Travel athletes will have 2 practices & 1 tumble class per week.

ANY PROBLEMS OR CONFLICTS SHOULD BE BROUGHT TO THE ATTENTION OF THE WORLD CLASS MANAGEMENT IMMEDIATELY AND NOT TO OTHER PARENTS AND/OR ATHLETES. NO DRAMA!

- World Class Athletics PCB maintains the right to refuse services at any time.
- World Class Athletics PCB may add, subtract or change any rule at any time.
- Good sportsmanship and good manners are mandatory for athletes and family members at all scheduled events. Please remember you are representing the entire WCA program.
- NO GOSSIP about any other child, parent or team(s) will be tolerated (school or all star). NO
 GOSSIP about WCA coaches, owners, and staff. If this policy is violated, you will be asked to
 leave World Class Athletics PCB immediately.
- Please remember that World Class is responsible for many children. Ensure your child's safety by
 dropping off/picking up <u>ON TIME</u>. Coaches are booked throughout the day and require the gym
 space for other teams, classes, and private lessons.
- You must arrive at all WCA scheduled events <u>ON TIME</u>. Punctuality is a must. Tardiness could result in indirect consequences for your child.
- It is your responsibility to wear the correct practice wear, hair-style, and bow to each practice.

 Conditioning will be given to those who do not comply. Please look presentable at each practice!
- During practice times, your opinions do not count. All decisions regarding the team are left to the discretion of the coaches. Please respect your coach's professional opinions.
- Please feel free to speak to your coach about anything. However, keep in mind there is always a time and a place. For example: approaching your coach during team practice, class time, a private lesson or in front of other parents is inappropriate.
- Practice times may be altered at any point in the season if necessary.
- Extra practices will be scheduled during the season when/if necessary.
- Anyone threatening to pull their child from a team may be asked to leave WCA immediately.
- Withholding a child from practice should never be used as a form of punishment. Please keep the disciplinary action(s) of your child separate from the sport.

- Homework will never be an acceptable excuse for missing a scheduled World Class event. Please plan ahead and schedule accordingly to complete all of your individual responsibilities.
- Never post negative comments on social media about World Class Athletics PCB. This includes (but is not limited to): Facebook, twitter, Instagram, Vine, KIK, text messaging, email etc.
- The coaches reserve the right to close practices to the public at any time for any reason.
- It is the responsibility of the parent to know what is going on at all times. Please check your email regularly and keep in touch with your Team Mom/Dad.
- Parents, relatives, and athletes are never to speak negatively to competition event staff. If you
 have an issue at a competition or event, WAIT UNTIL WE GET BACK TO THE GYM. Remember
 you are representing World Class Athletics PCB, owners and staff. Please do NOT try to handle a
 situation by yourself. It could result in an athlete, spectator, team or program being disqualified.
- There will be no arguing or questioning of the coaching decisions at practices or competitions.
- If a conflict arises and you feel it needs to be addressed, please contact CJ Green. A meeting will be set up for all parties involved to find a solution that is best for everyone.
- Alcohol or substance abuse at a competition or scheduled WCA event will result in immediate expulsion from the team. NO EXCEPTIONS!
- World Class may close practices to parents and friends if "parent issues" become distracting to the teams or coaches. Please mind your manners so that everyone has a chance to attend their child's practice time.
- Choreography camp includes a national championship caliber routine and professional music.
 Choreography camp is MANDATORY for all World Class athletes. If a member is unable to attend camp, the choreographer will build an open position for them and the Choreography & Music fee will still be charged. Choreography is based on the number of members built into the routine, not just those who are physically present.
- New and veteran members joining after camp must also pay the Choreography & Music fee in order to be put into the routine. There is no discount regardless of when your athlete joins the team.
 - All music, choreography, dances, stunts and pyramids presented to the athletes of World Class
 Athletics are to remain completely confidential. Routines and ideas should not be discussed,
 taught or shown to anyone that is not on your 2021-2022 team. NO EXCEPTIONS. Please help us
 remain a winning program by maintaining confidentiality.

2021-2022 COMMITMENT STATEMENT

All-Star cheerleading and dance is a competitive sport which necessitates practice, hard work, sacrifice, teamwork and commitment. I am willing to make the World Class Athletics PCB Program a top priority in my child's life and will do my very best to be as cooperative, supportive, flexible and understanding as possible. We understand the commitment that we are making as a family to the World Class staff, coaches and other team members. We intend to participate for the entire year from May 2021 to May 2022. If for some reason, circumstances occur which require our departure from the program; we do not expect any refund of fees or competition expenses and understand that we may not participate in another All-Star Program within 75 miles until the following season (2022-2023). I understand that fees are due on the 25th of the month. I understand that my provided credit/debit card will be automatically charged on the 25th of each month. If my account is not paid by the 1st of each month, there will be a \$20 late fee charged to my account. I understand that some days of school will be missed in order to attend competitions. I understand that teams practice a minimum of twice per week (excluding tiny, non travel or prep divisions) during our regular season and possibly an extra day during the week of a scheduled competition. I understand that my child is required to attend all World Class Athletics PCB scheduled performances, competitions and events. I understand that if my child misses practice the week of a scheduled competition, he/she will not be able to compete at that event. I understand that the teams plan to participate in approximately 10-12 performances/competitions per season. I understand that some events require overnight accommodations and travel arrangements (travel teams). I understand that a squad member can be dismissed from the team for missing an excessive amount of practices, any violation of the Program Code of Conduct or for any other inappropriate behavior World Class management does not approve of. I understand that consistent negative conversation and gossip will not be tolerated and will result in removal from World Class Athletics PCB. I understand that if my child quits or is asked to leave the program, my child is not allowed to participate in another All-Star program within 75 miles of World Class Athletics PCB. I understand that if my child does participate in another All-Star program within the duration of the 2021-2022 competitive season, World Class Athletics PCB will pursue legal actions. I have familiarized myself with the contents of this handbook. I acknowledge, understand, accept, and agree to comply with the program guidelines provided. I understand this handbook is not intended to cover every situation that could arise during the season. If my account balance is not current, I understand that my child will not be able to participate in practices and/or competitions until my balance is current. I understand that this signed commitment statement/non-compete contract will be maintained and enforced for the entire 2021-2022 season or for the duration of my athlete's participation in the World Class Athletics PCB All-Star Program.
